Addressing plastic waste pollution in Malaysia as part of the effort to combat climate change	Support	Through trade association, PCG is addressing plastic waste pollution by supporting the establishment of advanced plastic recycling industry in Malaysia. The trade association submitted a White Paper to the government outlining the opportunities presented by plastic waste, strategies for improved management, and ways to harness its potential. This approach aims to reduce dependence on virgin plastic materials, thereby indirectly contributing to lower greenhouse gas emissions throughout the entire process.  Besides contributing through its membership in the association, PCG actively provides input and feedback on the drafted proposal, drawing on its earlier development of the New Plastic Economy programme. This programme supports Malaysia's Circular Economy Roadmap, which is led by the Ministry of Environment and Water, aiming to advance sustainable plastic management and circularity in the country.
Promotion of cleaner energy as part of the effort to combat climate change	Support	Through its trade association, PCG is actively promoting the growth of the emerging cleaner energy market, particularly focusing on green methanol and renewable methanol as key sustainable fuel solutions.

As the official voice of the (MPMA) Malaysian plastics sector, MPMA represents its members in government interactions and spearheads the industry's growth by offering platforms that help members enhance their global competitiveness. MPMA's current focus includes upgrading the technological capabilities of the plastics industry, particularly by providing advanced technical training in areas such as Industry 4.0. In all its activities, MPMA places strong emphasis on social responsibility toward the environment, promoting sustainable practices to protect the environment and communities. Designed for use in classroom teaching and co-curricular activities, the module includes interactive content and videos to engage students actively, inspiring them to make responsible environmental choices. Since its introduction, the module has been distributed to thousands of primary and secondary schools nationwide, contributing to the broader objective of fostering environmental awareness and sustainability education among Malaysian youth
