The trade association presented to the government a White Paper that outlines underlying opportunities with plastic waste and how it can be better managed, potentials harnessed, and reducing reliance to virgin plastic materials, indirectly contributing to lower greenhouse gases emissions throughout the process.</p> <p>Aside from contributions via memberships to the association, PCG provides input and feedback for the drafted proposal, as PCG had earlier developed New Plastic Economy programme to support Malaysia's Circular Economy Roadmap spearheaded by the Ministry of Environment and Water.</p>
