

CAPACITY RELEASE EXERCISE (“EXERCISE”) FOR THE POTENTIAL SERVICES SUBSCRIPTION AT REGASIFICATION TERMINAL SG. UDANG (RGTSU)

1. Introduction

RGTSU

RGTSU began its commercial operation in the second quarter of 2013. The facility is owned and operated by Regas Terminal Sg. Udang Sdn. Bhd. (RGTSUSB). It is known as the world’s first-of-its-kind regasification unit on an island jetty. Two floating storage units (FSUs) are equipped at the facility to receive and store Liquefied Natural Gas (LNG) prior to being regasified and injected into Malaysia’s PGU network.

The technical specification of the terminal is as follows:

Maximum send-out capacity	3.8MTPA (500mmscfd)
Storage capacity	260,000 m3
Receiving LNGC	130,000 m3 to 220,000 m3
Length of jetty	980 m

Purpose of the Exercise

The Exercise will be part of RGTSUSB's initiative to support Malaysia's momentum towards achieving regional gas market hub status, aiming to offer a competitive regasification tariff moving forward.

2. Specific Terms for the Exercise:

Below are the specific terms for this Exercise:

- i. The Exercise scope is for regasification services.
- ii. Application is open to licensed shipper(s).
- iii. The Exercise application is to be made through submission of complete [Access Request Form \(ARF\)](#) within the specified timeline.
- iv. The Exercise is to be offered in accordance with the terms and conditions in Access Arrangement (AA).

3. PROCESS OF SUBSCRIBING REGASIFICATION AT RGTSU

Below are the steps involved in the process of subscribing regasification capacity, from the submission of the Exercise to the signing of necessary agreement(s):

- i. Applicant(s) to submit the Exercise application via ARF to RGTSUSB including the capacity required and duration no later than 1700hrs, 30 Sept 2026 Malaysian time.
- ii. The receipt of the Exercise acknowledgement will be furnished by RGTSUSB to the applicant(s) within five working days from receipt of the complete Exercise application submission.
- iii. RGTSUSB will assess the submitted documents based on operator's assessment criteria.
- iv. All applicants will be notified in writing on the Successful/Unsuccessful capacity application within thirty working days of assessment completion.

Important Note:

As part of operational requirements under AA, successful applicant(s) will enter into necessary agreement with other capacity user(s), upon advice by RGTSUSB.

4. Exercise Assessment Criteria

Exercise assessment criteria are including, but not limited to:

- i. Credit risk assessment
- ii. Legal compliance assessment
- iii. Technical and feasibility assessment
- iv. Any other assessment as deemed required by RGTSUSB and approved or acknowledged by Suruhanjaya Tenaga.

5. Exercise Submission Form

Submission as per [ARF](#) format.

6. Terms and Conditions for Exercise Submission

- i. Please submit the completed [ARF](#) to pgb.marketing@petronas.com by no later than 1700hrs, 30 Sept 2026 Malaysian time
- ii. RGTSUSB will treat any documents received as confidential. RGTSUSB may at any time request additional information, clarification, or confirmation with respect to the Exercise. The documents must be signed by applicant's approving authority and submitted to RGTSUSB in PDF format.
- iii. Any documents received after the no later than 1700hrs, 30 Sept 2026 Malaysian time shall not be considered.
- iv. All applicants will be notified in writing of the outcome of this Exercise.
- v. RGTSUSB shall retain its discretion as a reasonable and prudent operator in determination of the outcome of the Exercise assessment process in accordance with the assessment criteria.
- vi. RGTSUSB will notify all applicant(s) of any cessation or changes of the Exercise accordingly, if any.
- vii. Receipt of these documents by RGTSUSB or any other communication made between RGTSUSB, and the applicants shall not constitute an agreement between RGTSUSB and the applicants.
- viii. Any applicants who submit documents in response to this request will be deemed to have fully agreed to the above submission conditions and instructions.
