- PETRONAS Gas Berhad Group's revenue for the quarter ended 31 March 2016 sustained at RM1.1 billion, a marginal increase of 2.7% as compared to the corresponding quarter primarily driven by higher gas processing revenue in line with higher performance based structure income and regasification revenue attributed to higher storage fees.
- Profit before taxation (PBT) was RM578.7 million, a marginal improvement of RM7.4 million as compared to the same quarter last year.
- Profit for the quarter declined by 0.6%, primarily due to higher tax expense.
- Earnings before interest, taxes, depreciation and amortisation were higher by 3.3% in line with higher profit before taxation.
- Earnings per share dropped by 0.14 sen, in tandem with lower net profit attributable to ordinary shareholders of the Company.
- The Board of Directors has approved a first interim dividend of 14 sen per ordinary share amounting to RM277.0 million in respect of the financial year ending 31 December 2016.

1. BASIS OF PREPARATION

The interim financial statements have been prepared using historical cost basis except for certain financial assets and financial liabilities that are stated at fair value.

The interim financial statements have been prepared in accordance with the requirements of IAS 34, *Interim Financial Reporting* and MFRS 134, *Interim Financial Reporting* and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial statements are unaudited and should be read in conjunction with the Group's audited consolidated financial statements and the accompanying notes for the year ended 31 December 2015. The explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2015.

Within the context of these financial statements, the Group comprises the Company and its subsidiaries and the Group's interest in an associate and its joint ventures as at and for the guarter ended 31 March 2016.

2. SIGNIFICANT ACCOUNTING POLICIES

The financial information presented herein has been prepared in accordance with the accounting policies to be used in preparing the annual consolidated financial statements for 31 December 2016 under the Malaysian Financial Reporting Standards (MFRS) framework. These policies do not differ significantly from those used in the audited consolidated financial statements for 31 December 2015 except as described below.

There was no qualified audit report issued by the auditors in the annual financial statements for the year ended 31 December 2015.

4. MATERIAL CHANGES IN ESTIMATES

There were no material changes in estimates of the amounts reported in the interim financial statements of the Group that may have a material effect for the quarter ended 31 March 2016.

5. SEASONAL OR CYCLICAL FACTORS

The Group's operations are not significantly affected by seasonal or cyclical fluctuations of the business/industry.

7. PROPERTY, PLANT AND EQUIPMENT

Freehold land and projects-in-progress are stated at cost and are not depreciated. Other property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses, if any.

8. DEBT AND EQUITY SECURITIES

There were no issuance, cancellations, repurchases, resale and repayments of debt and equity securities during the guarter ended 31 March 2016.

The Board of Directors has approved on 9 May 2016, a first interim dividend of 14 sen per ordinary share amounting to RM277.0 million in respect of the financial year ending 31 December 2016. The interim dividend will be payable on 8 June 2016 to depositors registered in the record of depositors as at 25 May 2016.

The interim financial statements for the current quarter do not reflect this approved interim dividend. The dividend, will be accounted for in equity as an appropriation of retained profits in the financial statements for the second quarter ending 30 June 2016.

10. CHANGES IN THE COMPOSITION OF THE GROUP

The Company had on 10 February 2016, terminated the Shareholders Agreement (SHA) with Sabah Energy Corporation Sdn. Bhd. (SEC) and accordingly, had acquired the remaining 1% interest in Regas Terminal (Lahad Datu) Sdn. Bhd. (RGTLD), a subsidiary of the Group from SEC for a purchase consideration of RM1,000. Upon acquisition, the Group increased its ownership in RGTLD from 99% to 100%.

11. SEGMENTAL INFORMATION

The Group has four reporting segments, as described below, which are the Group's strategic business units. The strategic business units offer different products and services, and are managed separately because they require different technology and marketing strategies. The following summary describes the operations in each of the Group's reporting segments:

- Gas Processing activities include processing of natural gas from gas fields offshore the East Coast of Peninsular Malaysia into salesgas and other by-products such as ethane, propane and butane.
- Gas Transportation activities include transportation of the processed gas to PETRONAS' end customers throughout Malaysia and export to Singapore.
- Utilities activities include manufacturing, marketing and supplying of industrial utilities to the petrochemical complexes in the Kertih and Gebeng Industrial Area.
- Regasification activities include regasification of liquefied natural gas (LNG) for PETRONAS.

Performance is measured based on segment gross profit, as included in the performance reports to the Board of Directors as the Company believes that such information is the most relevant in evaluating the results of the segments.

The Group operates in Malaysia and accordingly, information by geographical location is not presented.

The segmental information in respect of the associate and joint ventures is not presented as the contribution of the associate and joint ventures and the carrying amount of investment in the associate and joint ventures have been reflected in the statement of profit or loss and other comprehensive income and statement of financial position of the Group.

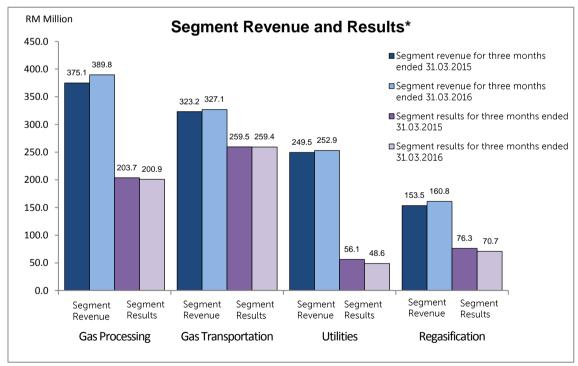

The Group's revenue for the quarter ended 31 March 2016 remained stable at RM1,130.6 million with a marginal increase of RM29.3 million or 2.7% as compared to the corresponding quarter. This was primarily contributed by higher gas processing revenue in line with higher performance based structure (PBS) income and higher regasification revenue attributed to higher storage fees.

Profit before taxation was marginally higher by RM7.4 million. Profit for the quarter however declined by RM2.7 million due to higher tax expense.

The following section will provide further analysis of the Group performance by operating segments.

Gas Processing

Revenue for the quarter ended 31 March 2016 improved by RM14.7 million as compared to the corresponding quarter mainly attributable to higher PBS income as a result of the plant's higher liquid extraction performance as compared to target.

However, Gas Processing segment results of RM200.9 million, was marginally lower by RM2.8 million due to higher depreciation expense in line with higher projects completed post quarter 1. FY2015.

Gas Transportation

Gas Transportation segment registered revenue of RM327.1 million for the quarter, reflecting an increase of RM3.9 million from RM323.2 million recorded in the corresponding quarter in line with higher capacity booking from PETRONAS. Segment results of RM259.4 million was comparable against same quarter last year due to higher repair and maintenance costs to improve asset integrity.

Utilities

Utilities revenue for the quarter ended 31 March 2016 rose by RM3.4 million to RM252.9 million, primarily contributed by higher average sales price in line with upward fuel gas price revision effective 1 January 2016. However, this was partially offset by lower offtake by customers.

Utilities segment registered results of RM48.6 million, a decrease of RM7.5 million as compared to the corresponding quarter due to higher operating costs.

Regasification

Regasification revenue for the quarter ended 31 March 2016 was RM160.8 million, an increase of RM7.3 million as compared to the corresponding quarter due to higher storage fees attributed to the strengthening of USD against RM.

Regasification segment results for the quarter were lower by RM5.6 million resulted from higher repair and maintenance costs.

The Group registered revenue for the quarter of RM1,130.6 million, lower by RM6.1 million as compared to the preceding quarter primarily due to lower booking capacity for Gas Transportation segment resulted from lower number of calendar days and lower storage fees for Regasification segment in line with weakening of USD against RM.

Profit before tax increased by RM90.5 million mainly due to lower operating costs partially offset by lower other income and unrealised forex gain in the preceding quarter. Accordingly, profit for the quarter was higher by RM36.3 million in line with higher PBT.

Excluding impact of forex and tax incentives recorded in the preceding quarter, profit for the quarter would have increased by RM110.3 million attributable to lower operating costs.

18. COMMENTARY ON PROSPECTS

The Group performance is expected to remain steady in 2016 amidst the challenging economic environment backed by its solid business models under Gas Processing Agreement, Gas Transportation Agreements and Regasification Service Agreement signed with PETRONAS respectively, whilst the Utilities segment performance will be dependent on demand from petrochemical customers.

The secured finance lease liabilities bears interest at rates of 9.13% (2015:9.13%) per annum. The unsecured term loan bears interest at rates ranging from 1.2% to 1.4% per annum and are due for full payment in 2021. Loan from corporate shareholder of a subsidiary bears interest at a rate of 6.5% per annum and repayable in tranches at their various due dates from 2018 to 2028.

Finance lease liabilities

As of 1 January 2016, the Group has adopted cash flow hedge accounting in which a USD denominated finance lease liability on floating storage unit time charter has been designated as a hedging instrument to hedge variability in cash flow from storage income that is attributable to foreign currency risk. The foreign exchange gain or loss on the hedging instrument is determined to be an effective hedge and is recognised in other comprehensive income until such a time that it will be reclassified from equity into profit or loss, in the same period during which the hedged forecast cashflow affect profit and loss.

22. BORROWINGS (continued)

Term loan

The Company had on 7 January 2016, executed a Facility Agreement with Mizuho Bank Ltd., Mizuho Bank Ltd. Labuan Branch and Mizuho Bank (Malaysia) Berhad for a USD500 million 5 year term loan facility. The term loan is unsecured and is subject to a floating interest rate.

In connection with the Facility Agreement, the Group have agreed on the following significant covenants on the Group with the lender:

- i. The ratio of debt to capital shall not exceed 1:1 ratio; and
- ii. The Shareholders' Funds shall not be less than RM10 billion.

Each of the above is determined from the latest audited financial statements of the Group.
