## A. ELIGIBILITY CRITERIA

- i. Applicant must be a Malaysian citizen NOT more than 22 years old
- ii. Applicant must NOT be under any other form of sponsorships.
- iii. Applicant has NO disciplinary cases or suspended during study.
- iv. Undergraduate Students:
  - Currently pursuing **approved** programme at a PETRONAS-**approved** university in the UK
  - Latest academic results equivalent to a minimum CGPA of 3.70 or First-Class Honours
  - Must have at least one full academic year remaining OR
- v. <u>Pre-University Students:</u>
  - Have secured a conditional offer or firm acceptance to pursue an **approved** programme at a PETRONAS-**approved** university in the UK

We seek exceptional candidates who stand out not only in academics but also in their engagement with extracurricular activities and community initiatives. Strong involvement in clubs, sports, competitions, community service, leadership roles, and other activities can greatly enhance an application.
